Objective/Purpose of Assignment:

Development of interaction system between entities in the road maintenance system aimed at ensuring the efficient operation of the system as a whole, development of new business processes aimed at ensuring effective decisions are made.

Scope of work:

- Conduct an analysis of the existing system of work and interaction between the Road Maintenance Department, Road Fund, SE "Kyrgyzavtozholdoru", MOTC KR (hereinafter entities);
- Develop internal instructions for the implementation and performance of functions provided for by the provisions on the establishment of organizations, the development of management schemes, a proposal for the organization and formation of operations with the separation of responsibilities and ensuring proper interaction with related organizations;
- Conduct a study aimed at the possibility of more effective interaction of entities in the road sector;
- Develop and prepare functional responsibilities and distribute responsibilities between departments and units in organizations to ensure the effective operation of the system as a whole;
- Prepare a scheme for managing and performing operations in each individual organization, taking into account the need for interaction and distribution of responsibility between entities.
- Organize and deliver two workshops on interaction in the new management system;
- If necessary, preparation of documents on amendments to existing Laws, legal acts and other regulatory documents;
- The consultant should coordinate and work closely with the RAMS-2 consultant on all matters related to this assignment;
- Assistance in the preparation and implementation of PPP projects;
- Carry out other tasks for the successful completion of work.

- 1. Internal instructions and regulations for the work of departments and units;
- 2. Schemes of interaction with the distribution of responsibility and the sequence of functions and the indication of departments and units of organizations;
- **3.** Schemes of management and interaction of departments and units in organizations with an indication of functional responsibility.
- **4.** Conduct two workshops (on organization of interaction in the new management scheme);
