The national road sector management reforming consultants team has been working on respective normative and legal acts regulating the road sector of the country, such as performance based contracts, public-private partnership, establishing state-owned enterprises, and has been preparing reports on works completed.

In addition, the Project provides for developing normative legal acts for enforcing Technical Regulation TP TC 018/2011 "On safety of wheeled vehicles" for purposes of institutional assistance to the Ministry of Transport and Roads of the Kyrgyz Republic.
