**Assignment Title: Financier-Economist**

The Government of the Kyrgyz Republic received financing from the Asian Development Bank toward the cost of the CAREC Transport corridor-1 (Road Bishkek-Torugart) (2755 KGZ(SF)) and intends to apply part of the proceeds for consulting services. Ministry of Transport and Roads of the Kyrgyz Republic established a group of national consultants on development, implementation and updating of legal and regulatory framework i.e., about 12 drafts of normative legal acts (NLA). The main parts of the NLA interconnected with each other, and are aimed at streamlining the work of MOTC KR road authorities from criteria for assessing of roads condition and planning of road works to acceptance of completed road works.
