The Kyrgyz Republic has received financing from the World Bank toward the cost of the First Phase of the Central Asia Road Links Program (CARs-1), and intends to apply part of the proceeds toward payments for goods to be procured under this project resulting from this IFB.

The Ministry of Transport and Communications of the Kyrgyz Republic (MOTC) now invites sealed bids from eligible bidders for Design, Supply and Installation of DWS equipment for Kemin and Sosnovka posts. More details are provided in the bidding documents.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's [*Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers \(dated January 2011\)*](#) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
