 - The Bidder must have successful performing at least three (3) contracts of installation and implementation of application software over the last five (5) years (2009-2013). This should be demonstrated by references to at least 3 clients in completed projects of similar complexity;

If it is Joint Venture each partner shall as a minimum comply with 15% from indicated requirements. At the same time together they shall follow general requirements.

The Bidder shall provide in is bid all technical specifications, technical schedules or other technical information on each item of the proposing Goods for the purposes of comparison of the given technical specifications in this bidding document and defining the conformity to the requirements.

The Bidder shall have its own resources and technical capacity to customize the product to be delivered. The bidder shall have experience in training end-users and IT specialists under project.
